EXPRESSION OF INTEREST (EOI)

BHEL, MAIN HOSPITAL, HARIDWAR DESIRES TO ENTER INTO RATE CONTRACT WITH SUPPLIERS (HAVING VALID DRUG LICENSE & GST CERTIFICATE) WHO HAVE THEIR OFFICE/SHOP WITHIN 15 KILOMETERES PERIPHERY OF BHEL, MAIN HOSPITAL FOR SUPPLY OF GENERAL MEDICINES/ANTI CANCER MEDICINES/SURGICAL ITEMS MANUFACTURED BY THE SPECIFIED FIRMS/BRANDS ON DAY TO DAY BASIS AGAINST DOCTOR'S PRESCRIPTION.

SUPPLIER WILL COLLECT THE PRESCRIPTIONS FROM MEDICAL STORE OF MAIN HOSPITAL, BHEL, HARIDWAR ON EVERY WORKING DAY AT 12.30 PM & 5.00 PM AND DELIVER THE GOODS BY 3.30 PM ON THE SAME WORKING DAY AND 12 NOON ON NEXT DAY RESPECTIVELY. HOWEVER IN RARE CASES MEDICINES MAY BE SUPPLIED DAY AFTER FAILING WHICH BHEL RESERVES THE RIGHT TO PROCURE THE MATERIAL FROM ELSEWHERE, THE BILL FOR WHICH WILL HAVE TO BE REIMBURSED BY VENDOR IN TOTO. PART SUPPLY OF ANY PRESCRIPTION SHALL NOT BE ACCEPTABLE.

SUPPLIER SHOULD BE PREPARED TO ACCEPT THE UNUSED MEDICINES SUPPLIED UNDER THE RATE CONTRACT BUT NOT TAKEN BY THE PATIENTS AFTER THREE DAYS.

TABLETS/CAPSULES ARE TO BE SUPPLIED IN STRIPS ONLY BEARING RATE, EXPIRY DATE AND BATCH NUMBER. THE SAME SHOULD BE CLEARLY MENTIONED IN THE CASH MEMO/BILL AS WELL.

INTERESTED SUPPLIER SHOULD SUBMIT THEIR APPLICATION TO MEDICAL SUPRINTENDENT, BHEL, MAIN HOSPITAL, HARIDWAR BEFORE 20.01.2018 BY 4.00 PM.
